Using the "MeltAway" cream in clinic with the plastic wrap tightens skin during the one-hour Body Wrap treatment, recommended weekly at beauty salons, aesthetic clinics, or day spas.

The cream penetrates skin cells, enhances blood circulation, removes waste fluids, and compresses fat chambers.

It prevents fluid loss through perspiration and helps fat cells release fluid and toxins.

You can perform approximately 15 body wraps using one 750ml tub of MeltAway, depending on the varying body sizes being treated. In-salon wraps can be conducted every 4days.

The EveryDay maintenance cream is designed for daily use at home to complement the concentrated MeltAway cream.

It aids in continued centimeter loss, prevents cellulite re-formation, and supports a healthy metabolic system and blood circulation.

When used with MeltAway, it moisturizes, tightens the skin, and forms a protective barrier against moisture loss.

Q & A

How often can clients come for a wrap?

Clients can have a wrap every 4 days. A minimum of 4 wraps at a 4 day intervals is recommended to see a result.

Suggested amount of wraps needed would depend on desired result and desired centimeter loss goal.

Can a client do one area only and not the entire body?

Yes, a client can wrap problem areas like just the stomach, thighs, buttocks or upper arm individually. However it is advised to do the full body wrap to achieve the best results.

How do clients maintain the results they achieved through the Body Wrap?

Once desired results have been achieved it is recommended that clients have at least 1 wrap per month and continue with homecare EveryDay. It is also recommended that clients stick to healthy eating habits & consume adequate amounts of water in order to maintain results achieved.

How effective is the EveryDay as a stand alone?

MeltAway Body Wraps are essential for targeted results. Everyday is a lessconcentrated formula of the MeltAway. So Everyday alone will not deliver the same results as effectively and timeously.

How does it work?

The MeltAway cream used during the in salon treatment accelerates metabolism to break down fat into carbon, hydrogen, and oxygen components.

Subsequently, these components, along with trapped fluids and toxins, are absorbed into the bloodstream and eliminated as waste. Notably, there is no loss of water through perspiration, and therefore, no increase in size when water is consumed.

This process aids in reducing the visible "orange peel" effect and cellulite centimeters, representing a natural body process that is often hindered by the presence of toxins.

Importance of Consultation:

Preparation prior to treatment:

Prior to and straight after the first wrap, measurements are charted.

Client will be measured again after the 4th/8th/12th Wrap Treatment.

Do:

Lie completely still during the 1hr wrap
Drink 8-10 glasses of water per day & add Celtic Salt to optimise cellular absorption, and aid in waste elimination.
Take a pinch of salt under the tongue for each 250ml water consumed.

Use the Everyday Home Care cream 1 x per day for optimal results & maintenance. Clients may exercise after a treatment.

Do not:

Use a sauna, steam room, sauna blanket, or heat pad whilst the wrap is on - sweating must not be promoted.

Use on the same day as other Body Contouring Treatments, such as Fat Freezing, Melting EMS
- wait 2 days between.
